The roof had leaked occasionally during periods of prolonged rainfall. The origin of the leak was where the original chimney exited the roofline. This chimney was disconnected from all exhaust in 2020 with new furnace, and shortly thereafter a new roof was installed (September 2020). No further leaks have occurred. Since the chimney was non functional - during new roof installation it was demolished down below the roof line and then sealed over.

During significant periods of heavy rainfall (7+ days of consecutive measurable rainfall) during 2019, there was a small amount of water that entered the basement near the southeast corner (near washer/dryer). It was determined that due to the age of the property and the rising water table from excessive rains that water would find its way up through the floor cracks. The water did not flood the basement and was contained to that corner of the basement. Was absorbed into the ground approximately 1-2 days after rain stops.
